Sections 22, and 64, Sale and Supply of Alcohol Act 2012

Pursuant to the Sale and Supply of Alcohol Act 2012 (the Act), **Good Creations Limited** (the licensee) is authorised to sell and supply alcohol on the premises situated at **272 Glenmore Road Coatesville 0793** and known as **D:Stil Project**, to any person attending the following occasion or event (or series of occasions or events): Gin Making School nights for consumption on the premises and to let people consume alcohol there;

And also to sell or deliver alcohol on or from the premises to any person for consumption off the premises and to supply alcohol free, as a sample, for consumption on the premises, to any person attending the occasion or event (or series of occasions or events).

(Except where the District Licensing Committee grants an exemption under section 213(2) of the Act) The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

CONDITIONS

This licence is subject to the following conditions:

- (a) Drinking water is to be freely available to customers from the teaching area.
- (b) Alcohol may be sold under the licence only on the following days and during the following hours:

- (c) The licensee shall have available for consumption on the premises, at all times when alcohol may be sold and supplied under the licence, a reasonable range of non- alcoholic refreshments and low alcoholic beverages and food appropriate to the occasion.
- (d) Information regarding and assistance with alternative forms of transport must be available.
- (e) A certificated manager is to be on Duty at all times.
- (f) The following steps must be taken to ensure that the provisions of the Act relating to the sale of alcohol to prohibited persons are observed:
 - (i) Ensure that no intoxicated persons are allowed to enter or to remain on the premises.
 - (ii) Ensure that appropriate signs are prominently displayed detailing the statutory restrictions on the supply of alcohol to minors and intoxicated persons adjacent to every point of sale.
- (g) The whole of the premises is designated as a **restricted** area.

THE LAW

Intoxication

Intoxicated people are not permitted on licensed premises. It is an offence to allow persons to become intoxicated here. It is an offence to serve an intoxicated person.

Intoxicated people will be required to leave.

Minors

A current NZ driver's licence, a passport or Hospitality NZ 18+ card are the only types of ID that we can accept.

If you look under 25, you may need to prove your age.

It is a condition of our licence that **food, low and non alcohol drinks and free drinking water** are available at all times.
